

# CAREER OPPORTUNITY Manager, Airfield Maintenance & Environmental Affairs AIRSIDE OPERATIONS & PUBLIC SAFETY

#### **JOB SUMMARY:**

The job ensures the airfield is safe for flight operations and maximizes asset life cycles through regularly scheduled maintenance and rehabilitation strategies. The job also ensures environmental sustainability through the implementation of policies, procedures and programs in accordance with applicable regulations and industry standards.

#### **KEY DUTIES AND RESPONSIBILITIES:**

- Analyzes and oversees the daily upkeep and maintenance of the airfield which includes but is not limited to pavement surfaces; grass verges, obstructions, lighting, signage, markings, equipment maintenance, perimeter security line and ditch clearance;
- Ensures all airfield facilities/operating practices meet the requirements of all applicable local Bahamas Aviation Safety Regulations (BASR);
- Develops effective asset management strategies (including pavement) to ensure safety and maximize the lifecycle of all airfield assets;
- Works effectively with the Maintenance Department to ensure reliable airfield lighting;
- Researches, plans, and develops environmental procedures and plans;
- Coordinates all aspects of pollution control, waste management, recycling, environmental health, conservation and renewable energy;
- Promotes and raises environmental awareness at all levels internally and with external partners, particularly the impacts of emerging environmental issues;
- Ensures compliance with all applicable company & government environmental regulations;
- Works with airport stakeholders & contractors to ensure the airport community is environmentally responsible and meets or exceeds international best practices;
- Acts as a liaison with government agencies or departments and contractors on environmental matters:
- Assists with the management of the airport's wildlife control program;
- Supervises and directs the day to day activities of the Airfield Maintenance and Environmental team;
- Develops and monitors annual budget for the upkeep and repair of airfield assets;

### **QUALIFICATIONS:**

- A minimum of a Bachelor's degree in Civil Engineering
- At least five (5) years' experience in a managerial capacity, preferably within the aviation industry
- Specific knowledge and/or experience in the areas of Asphalt pavement surface maintenance, surface and groundwater management, solid and hazardous waste management would be a plus
